\$5 e-Movie Cash Certificate Towards a Movie Ticket to see *The Peanuts Movie* with receipt submission of purchase of \$10 or more all® Laundry Products

How to Participate: Purchase \$10 or more (in retail value before coupons and taxes) of any all® Laundry Products in a single transaction between 9/1/15 and 11/15/15 at a retailer (online retailers are limited to Amazon.com and Walmart.com only) selling all® Laundry Products (hereafter, "Eligible Purchase") and you will be eligible to receive a \$5 e-Movie cash certificate towards a movie ticket to see ***The Peanuts Movie*** (subject to compliance with these Official Terms & Conditions). Valid towards in-theater purchases only. A. Submit via Email or Text:

1. Place a checkmark on your receipt next to the retailer's name/logo, eligible product(s) purchased, date and time of purchase and receipt total (hereafter, "Receipt").
2. Scan or take a picture of the original, dated Receipt from your Eligible Purchase. Picture cannot exceed 5MB in size.
3. Email or text to code@allpeanutsmovie.com between 12:00:00 am (midnight) Pacific Standard Time ("PST") on 9/1/15 and 11:59:59 pm PST on 11/30/15 (hereafter, "Redemption Period") and attach your Receipt (hereafter, your "Receipt Submission"). Shortly after the receipt of a submission via text or SMS message, you will receive one (1) text response from TPG Rewards Inc. to the mobile number used to submit the receipt notifying you of the status of your submission. You will receive either a code to receive your ticket to The Peanuts Movie or an error message why the receipt submission could not be processed. 6. Download and print your Certificate, and present it at any participating theater in the 50 U.S./D.C. to see ***The Peanuts Movie***. For a list of participating theaters, see www.emoviecash.com/locator.

7. The Certificate can be printed one (1) time for up to seven (7) calendar days after you have received a confirmation email. After seven (7) calendar days, you will no longer be able to print your Certificate.

3. After Upload of your Receipt submission you will receive a confirmation of your submission on your screen followed by a reply email. The reply email will notify you the status of your submission. You will receive either a code to receive your ticket to The Peanuts Movie or an error message why the receipt submission could not be processed. Once you have a code, visit www.allpeanutsmovie.com and follow all on-screen prompts and instructions to enter and submit your code and any other required information. Codes expire on December 31, 2015.
4. In return, you will receive a Certificate, which will constitute one (1) \$5 e-Movie Cash Certificate towards the purchase of a ticket to see **The Peanuts Movie**.
5. Download and print your Certificate, and present it at any participating theater in the 50 U.S./D.C. to see **The Peanuts Movie**. For a list of participating theaters, see www.emoviecash.com/locator.
